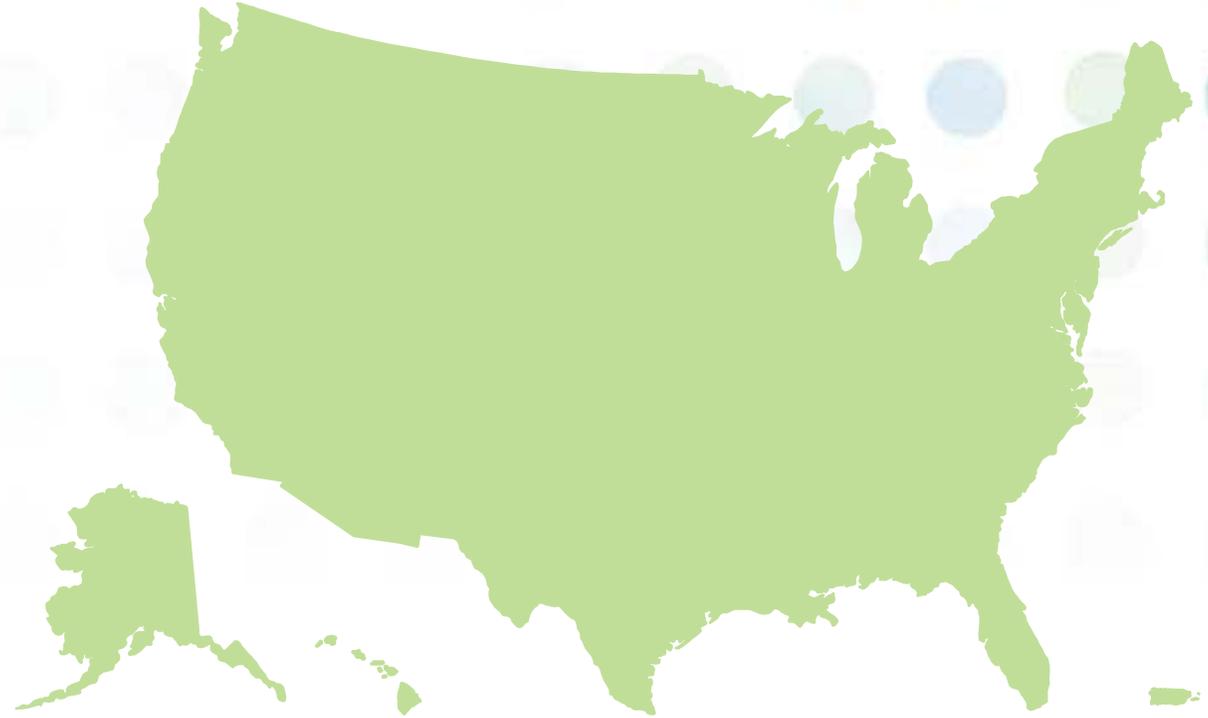

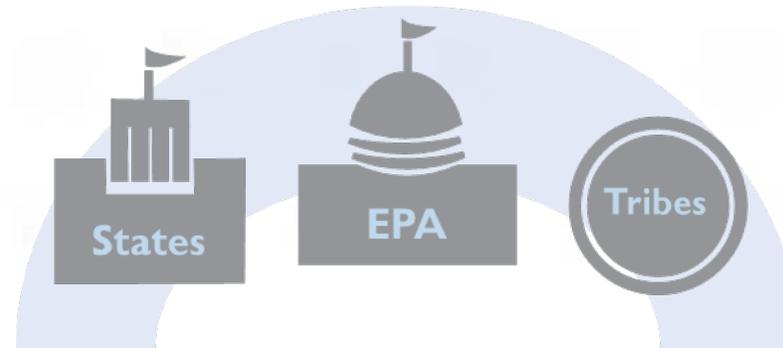

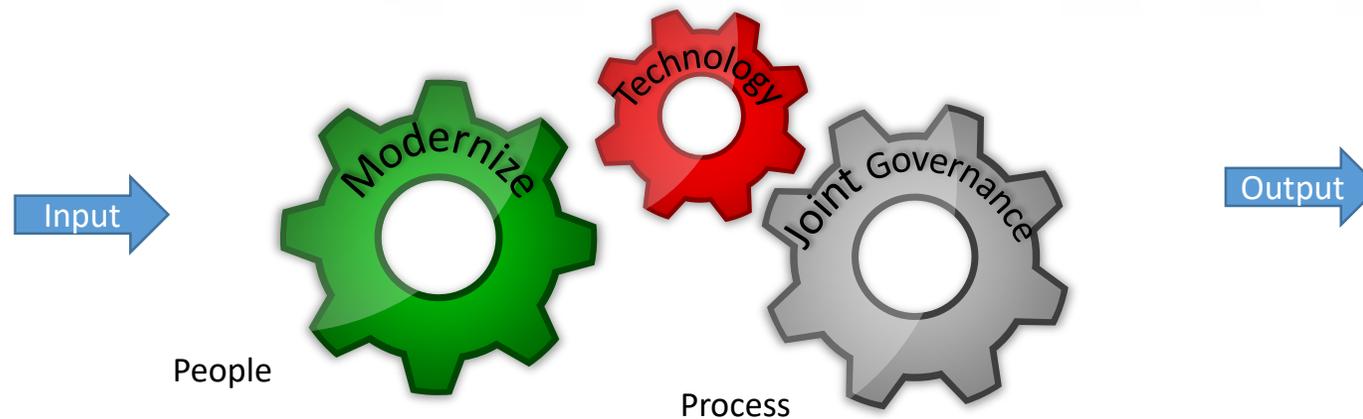

State Plan Electronic Collection System (SPeCS)

An integrated electronic submission, review, and tracking system for State Implementation Plans (SIPs) and other air agency submissions that enables EPA and SLTs to:

- Manage plan submission and review process more efficiently and effectively;
- Increase transparency through greater “real-time” data availability; and,
- Enhance collaboration among different levels of government.
